California brake cleaner regulations:

- Penray 4720 (3% VOC) and 4920 (10% VOC) are valid part numbers for sale in all of California.
- The South Coast Regions (SCAQMD) and the Sacramento area (SMAQMD) do have restrictions on VOC limits.
- The shop can use as much Penray 4720 per day as needed because it does not exceed 3% VOC.
- Penray 4920 can be used in volumes not to exceed 160 fluid ounces per day, per CARB regulations.
- It is the responsibility of the user to monitor their usage.

VOC- any compound (other than carbon monoxide or dioxide, carbonic acid, metallic carbonates or carbides and ammonium carbonate) which participates in atmospheric photochemical reactions.
